ing to develop family-friendly and conservative -leaning films. Please help support Jonathan's effort and the local Republican Party by planning to attend.




Commissioners choose Will Payne to serve as Prosecuting Attorney

Ecology Petitioned to Amend Burdensome Water Rule

Olympic Resource Protection Council (ORPC) has filed a petition with the Department of Ecology (DOE) to amend the Dungeness Water Management Rule. ORPC has been critical of the rule because of its significant and unnecessarily costly impacts on Clallam County residents seeking to develop or redevelop their properties consistent with established county land use designations and planning policies. Given the recent ruling by the WA Supreme Court in the Swinomish v. Ecology case, ORPC has further concerns regarding the lack of legal authority for the rule.

ORPC is hopeful DOE will address the points raised in the petition, some of which include:

The need for DOE to use its existing reservation authority to set aside a sufficient quantity of groundwater, as required under the Water Resources Act, to meet the demand for domestic water under the County's long-range land use planning; this instead of utilizing "overriding considerations of the public interest" (OCPI) to create a reservation.

Taking into account the past investments which have been made to restore streamflows, such as the 30 cfs permanently held by the State for instream flows.

Conducting the required maximum net benefits test since DOE set instream flows in excess of base flows.

DOE's recent approach to instream flow rulemaking has caused widespread uncertainty; created direct conflicts with local land use planning authority; and imposed significant regulatory and transactional costs that are out of proportion to any identified benefits. ORPC urges DOE to amend the rule and work with all stakeholders to craft a balanced, lawful and effective water management rule for the Dungeness Basin.

Additionally, ORPC hopes the Swinomish decision will prompt a reassessment of DOE's rulemaking authority and that there will be legislative clarification of the appropriate balance of water supplies for people, farms, and fish.

The petition process is afforded under RCW 34.05.330 and requires the agency to provide a written response within 60 days of receipt. Under this statute the agency must choose one of two alternatives: it can deny the petition or engage in rule-making. If they deny the petition, they must specify its reasons for the denial and specifically address concerns raised in the petition. Where appropriate, the agency must indicate alternative how the agency will address the concerns raised in the petition.

New IRS Rules would quash first amendment rights; Congressman introduces bill to block the move

Over the past year or so, there has been an ongoing investigation by the U. S. House of Representatives over allegations that the Internal Revenue Service (IRS) has specifically targeted conservative and Christian organizations. The hearings are still going on. Now, the IRS has quietly issued a proposed set of new IRS regulations, which, if implements, will permanently muzzle conservative 501©(4) nonprofit organizations and their individual employees. The 501©(4) designation covers social welfare organizations. The proposed new regulations would compel a 90-day blackout period during election years in which conservative 501©(4) organizations – like tea party groups, pro-life and pro-family groups, would be banned from mentioning the name of any candidate for office, or even the name of any political party.

Lobbying groups like labor unions and trade associations are exempted. The regulations would prohibit conservative organizations using words like "oppose," "vote", or "defeat." The restrictions may apply to 501©(3) organization in the future. According to Mat Staver, chairman of Liberty Counsel Action, one of the core liberties in our constitutional republic is the right to dissent, and that is being taken away. Specifically, here's what the proposed regulations would do to conservative groups and their leaders:

- Prohibit using words like "oppose," "vote," "support," "defeat," and "reject."
- *Prohibit* mentioning, on its website or on any communication (email, letter, etc.) that would reach 500 people or more, the name of a candidate for office, 30 days before a primary election and 60 days before a general election.
- *Prohibit* mentioning the name of a political party, 30 days before a primary election and 60 days before a general election, if that party has a candidate running for office.
- Prohibit voter registration drives or conducting a non-partisan "get-out-the-vote drive."
- Prohibit creating or distributing voter guides outlining how incumbents voted on particular bills.
- *Prohibit* hosting candidates for office at any event, including debates and charitable fundraisers, 30 days before a primary election or 60 days before the general election, if the candidate is part of the event's program.
- Restrict employees of such organizations from volunteering for campaigns.
- Prohibit distributing any materials prepared on behalf a candidate for office.
- Restrict the ability of officers and leaders of such organizations to publicly speak about incumbents, legislation, and/or voting records.
- Restrict the ability of officers and leaders of such organizations to make public statements regarding the nomination of judges.
- Create a 90-day blackout period, on an election year, that restricts the speech of 501(c)(4) organizations.
- Declare political activity as contrary to the promotion of social welfare.
 Protect labor unions and trade associations by exempting them from the proposed regulations.
- U. S. Congressman Dave Camp (R-Midland), and Chairman of the House Ways and Means Committee, has introduced a bill—H.R. 3865—"Stop Targeting of Political Beliefs by the Act of 2014" to stop the targeting of conservatives by the IRS. He has led the investigation into the IRS's abuse of conservative groups. He said, "Congress must make sure every American's right to participate and engage in civic debate is protected, and this legislation will provide some much-needed assurance that IRS targeting and surveillance will not continue."


WSRP Chair Susan Hutchison Demands Public Disclosure Commission Do Its Job

BELLEVUE, WA – Washington State Republican Party (WSRP) chairman Susan Hutchison released the following statement today:

"Following a report from Austin Jenkins on the Democrats' shadowy hidden money network in our state, I am demanding the Public Disclosure Commission (PDC) continue its investigation into Tom Steyer, the California billionaire who registered his NextGen Washington PAC at the offices of Progress Alliance and whose checkbook was maintained by Washington State Democratic Party chair candidate and current Executive Director of the Win/Win Network, Dana Laurent.

"Tom Steyer has consistently falsely reported his activities in our state, and the PDC is failing in its duty to hold everyone accountable to our state's campaign finance laws. California billionaires do not get special treatment, and I call on our campaign finance watchdog to do its job to ensure fairness in Washington State elections."

On October 23, 2013, the WSRP filed a complaint with the PDC against Tom Steyer following his illegal \$3 million contribution to his NextGen PAC, which was well beyond the Washington State law limiting contributions to political committees to \$5,000 in the last 21 days before an election. Steyer claimed that the organization was done doing business in Washington, though evidence soon surfaced that NextGen was still doing business 11 days after the lie he told the PDC regarding his activities. The PDC has yet to administer a ruling or even conduct an investigation on the renewed complaint the WSRP filed on October 31, 2013.

The Growth Management Act: Just another Central Planning Failure

On Jan. 16, thanks largely to Senator Pam Roach (R-Auburn), the Washington State Senate provided an opportunity to discuss the Growth Management Act (GMA) in a public work session. Last year, I wrote about a less formal work session held by Representative Dean Takko (D-Longview). However, the recent Senate work session demonstrated notable willingness to look at Washington State's GMA in a comprehensive manner without constraining the comments of those who testified. The complete video from the hearing is at the Freedom Foundation website (starting at about 37 minutes).

Experts from Futurewise (pro-Central Planning), CATO, Freedom Foundation, National Federation of Independent Businesses (NFIB), Citizens Alliance for Property Rights (CAPR), and others offered a variety of testimony. In addition, two current County Commissioners and one former legislator testified, and the citizens who spoke came from all over Washington, including counties like Pend Orielle, Whatcom, San Juan, Thurston, Island, Pierce, and King.

The hearing room was packed-- standing room only. The overflow rooms were also full of citizens watching the work session, and many people were hovering outside the doors, hoping to fill any vacated seat. The testimony at this hearing speaks for itself, and this open public GMA work session was

This fact, along with the high degree of public interest and the significant use of local and state resources to comply with the GMA, makes this televised work session remarkable.

Under previous Washington State Senate regimes, led largely by the Democrat Party, a public discussion was never allowed partly because few GMA supporters want to question the impact of its mandated centralplanning schemes—let alone the dangers of central planning in general. As I state in my comments at this hearing (see 1:51:37), the Freedom Foundation's official policy is that the GMA should be repealed. As Property Rights Director, I recognize the great harm this law has directly caused for citizens and their communities alike. Many of the people testifying also understood the problems and described them. For instance, Randy O'Toole discussed the fallacy of Compact Developments and their "benefits" to the environment. He has also written several papers on this subject attached here.

Commissioner Skoog from Pend Orielle County and Commissioner Emerson from Island County discussed the real and costly impacts of trying to manage small counties under GMA-imposed restrictions and litigation. Additionally, Ed Kilduff, a scientist from San Juan County and Roger Almskaar from Whatcom County discussed problems introduced by faux science and goofy assumptions under the GMA. Charlie Conner from King County explained how the GMA forced developers to get big and go for mega developments, only hurting the little guy in the process. Larry Castello, also from King County, discussed how the GMA encouraged land use policies in King County that ignore property rights (listed as a right in the Washington State Constitution) and emphasize penalties, fees, fines, restrictions, and restraint against citizens.

Senator Roach also pointed out that the Washington State Association of Counties (WSAC) does not represent the rural or small counties very well at the Legislature. If I were a lobbyist at WSAC, I would take a close look at how they represent their smaller counties.

If you're a citizen concerned about property rights, you should listen to all of these testimonies. (You may enjoy Senator Roach's description of a memorable helicopter ride over the Yakima Reservation, too.)

In the recent 2014 Index of Economic Freedom rankings published by the Heritage Foundation, the United States is slipping further down the list of "mostly free" nations. Exploding debt and the erosion of property rights have accelerated this downward rankings trend for the United States. In Washington State, the GMA has been the primary vehicle for destroying individual property rights. Washington State modeled its GMA on Florida's "Smart Growth," a central-planning approach with an Orwellian name. Florida discovered the central planning business was not a good use of their resources, so they rejected this scheme in 2011. We hope Washington State doesn't have to continue down this harmful path much longer before we can convince our elected leaders to reject it, as well. Thursday's hearing is just the beginning and will hopefully initiate the dialogue that can move Washington toward more freedom in the future.

In politics, there are no guarantees, and there is no such thing as Utopia. Politics is all about the art of the possible, and it is unlikely the GMA would be repealed tomorrow. Yet Thursday's hearing was a great opportunity to start exposing the truth about central planning in Washington State and forcing our elected officials to pay attention to this issue. For this opportunity, we should thank Senator Roach and her fellow state senators for being willing to initiate the discussion.
